The Ordering Party will select the best object of order by granting points for meeting the net price criterion. An offer/proposal shall be deemed the best when it receives the highest number of points, whereby the principles for granting points are as follows: The "net price" criterion: The proposal with the lowest price receives 100 points. The remaining proposals will receive points in a linear way (with accuracy of two decimal places) in accordance with the following arithmetic formula: (X÷Y) x 100, whereby: X = the lowest price quoted, Y = the price of the proposal concerned in the calculation.
Proposal drafting requirements:	As a minimum, the submitted proposal shall contain the following information: Name, NIP number (Taxpayer's Identification Number) and address of the Offering Party or the Offering Party's official business stamp. Date of proposal issuance, A description of parameters of the proposed object, with reference to the required parameters listed in the Request for Proposals. Unit price (net and gross) of the entire object quoted in PLN or in EUR. If the Offering Party chooses to submit their proposal in EUR, the amount in EUR must be converted to PLN in accordance with the
